3. **Campaign Period:** Entries will be accepted online starting on Thursday, October 1/ 2020 at 9:00 am MST and ending Saturday, October 31/2020 12:00 pm MST. All online entries must be received by Saturday, October 31/2020 12:00 pm MST.

The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize.
